Why are we being consulted on the caption and not on whether HKTV should be given their free-to-air license? The consultation process is a farce and important decisions are made without public consultation.

For the records, I wrote to LEGCO in October with the following communication:-

As a member of the public, the denial of a free-to-air license to HKTV is of the gravest concern to me. Freedom of speech is one of Hong Kong's cornerstones, our loss thereof would be like a professional athlete losing his legs. The clandestine approach the administration took and the PR that followed were both unsatisfactory. They appear to be the work of a communist organisation; surreptitious and underhanded.

I am extremely dissatisfied with the government's denial of free-to-air license to HKTV. Reversal of the decision is the only course of action that can restore our faith in the system.

Dear PCCW/ Ms

Please see below for our input to the PCCW consultation. We live in Wang Tong Village Mui Wo. Our internet service was broken again yesterday. This is the 9th time it has broken since we moved in in 2011. I work from home my business is affected each time it breaks down.

We have a Max internet speed of only 3mb and once the Now TV is on this is more than halved. This is just not acceptable for the price we pay, given that it is faster in most other areas around Mui Wo, and even in other areas of Wang Tong.

I have tried to make formal complaints around 3 times before and PCCW have each time refuse to accept these.

Our PCCW account number

The Internet and now TV has done down around 9 times since we set it up in 2011 and this instability means that it is tricky to work from home sometimes, which affects our business.

In September 2012 the internet went down 3 times and finally PCCW came in early sept 2012 and did nothing to fix this in the house.

It was down for a full week from late sept 2012 to 5 oct 2012

I complained again on 3rd Oct 2012, spoke eventually to manager

the duty

I tried to make a formal complaint but PCCW refused stating I had to complain again after the technician visited

The technician came Friday 5th oct 2012 and changed the modem, and it stated working again

We discussed the connection speed, why only 3mb per second.... In tai tei tong 8Mbps, in Wang Tong house numbers #3-20 6Mbps, why only 3mb here?

They say it is something to do with the old cable, and I have asked how to improve this as not acceptable for the money we pay, particularly given that other households in the area have faster speeds for the same price

The technician said he would talk to his supervisor as another team is responsible for the connection speed

He advised to turn off now tv when using the internet as this improves the speed, checked this on www.speedtest.net and it was 3Mbps with the nov tv off nd 1.25Mbps with now tv on

We never heard back from his supervisor as to the slow speed or to how to improve the cable.

It is ridiculous to pay so much for the internet and now TV given the slow speed. It is so slow that the services offered with Now TV are not possible to access, such as the TV on demand services that we have no choice but to pay for as they are part of the package.

There are no other service providers so we have no choice but to use PCCW.

I have never come across a company with such bad customer service as PCCW given the monopoly they have and the price we pay. I must have spent over 10 hours on hold trying to call PCCW over the last couple of years with no real improvement of service.

In 2013 the price for Now TV and the internet was increased significantly (around 70% I think) and we actually had a decrease in service quality. It is urgent that they put in better infrastructure e.g. New Cables to justify the price we pay

Stifle competition

Hong Kong Television Entertainment Company Limited (HKTVE) under the umbrella of the PCCW Group has been granted the free television program service license in principle. PCCW owns both domestic free and pay television license may have stranglehold on the television market.

Tariff increasingly pricey

Since subscribing to PCCW pay television service for about 10 years, tariff has been adjusting only upward in every renewal.

Penalize incumbent customers

No discount for existing customers but newcomers.

Discriminatory Pricing

Tariff is not charged fairly in different market segments. Only customers in public housing can enjoy discount rates.

Coercing customers into subscribing Barclays Premier League (BPL) service

Customers used to subscribe Fox Sports and Star Sports independently regardless of other sports channels. Coercing customers into subscribing BPL service, PCCW has rescinded the said arrangements, and imposed a sports combo of 17 channels on intended customers neglecting theirs preferences. Customers' right of choice are dreadfully compromised and trammeled.

Shriveling complimentary channel - "now 100 Hong Kong"

"now 100 Hong Kong" used to be a paid channel. Paid channels: "now 101", "now Entertainment", "now Mango", and "now HaiRun" were established eventually, ever since "now 100 Hong Kong" was changed to a complimentary one. Input of resources into the production of "now 100 Hong Kong" has been reduced tremendously. At present, most programs broadcasted in "now 100 Hong Kong" are replays of "now 101" channel. Complimentary channels also demand investment to ensure innovation and quality.

My experience of dealing with PCCW has been nothing but dreadful. They are quite

literally the worst and most dishonest company I have ever dealt with. They are deceptive and sneaky in the way they deal with their customers and the service is pathetic. (Try calling the 'Hotline')

I have been asked to pay for items that do not work, for things I did not ask for and locked into contracts

even where I just move a telephone line. My bill have progressively climbed.

They placed two identical decoders in my flat stating that one was free and then later charged

me for the 2nd unit showing mostly the same channels as the first on the same TV.

When I refused to pay they threatened to take me to court unless I paid the bill for 2 years ahead or HK\$5000+

They also bundled the Internet so that when I refused to pay for something that I did not ask for,

i.e. a 2nd decoder on the same TV they

then switched off my internet even though this is paid up to date.

When you try to reason with their sales department it is impossible and they get quite rude.

I have asked to see copies of the contract for the 2nd decoder (The original contract was signed by my wife)

but they say this is confidential within the company. The reason is it does not exist as we only signed for one.

They list out the channels for the first decoder on the bill but not for the 2nd one even though I have asked many times

because they know it would show the same channels.

The 2nd decoder has not worked for about 6 months and anyway I never used it as its the same as the first.

My bill is around HK\$1000 per month in total.

I have not heard anyone who likes their service.

Do not renew the licence. They are awful.

Allow a new company to come in --- PLEASE!!

Essentially, PCCW advertised A la carte service is not available for costumer who wishes to but a single or specific channel only. We are now forced to pay for a package price even if the package contains many channels that I have no interest in watching. Typical example, is Now TV sports pack where they have included the Barclay Premier League intone Sports pack forcing consumers to pay to watch football even if they have no interest in football.

As the Communications Authority, you have a responsibility to safeguard consumers interest and to promote fair business practices. PCCW is acting in self interest only, and the consumers are penalized by having to pay more to watch TV programs.

I would advocate that as a government body you should put a stop to PCCW business practices of gouging the consumers, and do away with exclusive content licensing like the Singaporean Government who truly looks after the interest of the public. PCCW license should not be renewed unless public interest is protected.

I understand that OFCA is currently inviting comment concerning the performance of PCCW NowTV (Pay Television License). As a subscriber of NOW TV, I have the following observations and comments.

1. I strongly suggest PCCW allows for major sports events (short duration) to be subscribed on an "event to event" basis (eg Cricket the Ashes event or Rugby World Cup event), rather than forcing a subscriber to pay for a channel for one year. Not only PCCW is effectively stretching out my overall subscription unfairly (as every additionally subscribed channel has a different expiry date), it is also forcing me to pay for contents that I don't need (basically a penalty for liking sports).

May I also add that while I was living in Thailand and Singapore, both pay TV operators (True Corp and Starhub) allow event only subscription. It is clearly a case where the subscriber agrees to pay for the event, the operator turns on the signal, then turns off the signal when the event is over.

Frankly I don't like to be held hostage by NOW TV this way. I like to have choices.

2. I would like to see less English channels being cancelled (such as MGM).

Please take my observations into consideration.

I wish to provide feedback on the provision of TV service by PCCW Ltd.

My wife and I are residents of South Lantau and receive a basic TV service from PCCW in addition to broadband services.

PCCW currently provides a 8Mbit/sec service in my location along with TV service. The available bandwidth on this line when TV service is enabled drops to about 3 MBit/second. Even when TV service is not enabled the Bandwidth is 7Mbit/second at best.

I would like to see PCCW be required to improve its residential broadband service to South Lantau locations and provide the same level of service at the same price to rural locations in HK that it does to urban areas.

The most recent survey of OGCIO suggests that the average access speed to the Internet in HK is over 56Mbits per second. Since we are unable to get service above 3Mbits/second from the only service provider in South Lantau when using TV service I believe that the infrastructure required needs to be upgraded to enable all residents to enjoy this service.

I would be grateful if you consider this input in your review of the TV license.

Dear OFCA.

Please see below my comments regarding PCCW's pay-tv service.

I have been a subscriber to PCCW's NowTV service for over 10 years and currently have 3 installation addresses under my control. I am very familiar with their service, and I have constantly been giving them feedback on the items listed below but I have never had any satisfactory solutions.

- 1. Monopolistic pricing practices because there is no competition for the English language and Sports packages I am interested in, I do not have an alternative to PCCW (Cable TV etc do not have the content I require). As such PCCW increases my package price at every contract renewal, which is contrary to other service providers such as mobile phones who can offer more for less money. The Sports package is particularly unreasonable, since PCCW won the tender for the English Premier League and they are covering this cost by raising the price of the whole sports package. I am not interested in football nor the poor content of Now Sports 1-7. I only require the independent channels Star Sports and Fox Sports. However PCCW will not allow me to get these 2 channels unless I get their Now Sports bundle and the price increase is unreasonable (around 100% for the sports package). As a result I had to cut the sports package on one of my accounts, and I fear I will have to cut it again upon renewal of another account.
- 2. Poor broadcast quality the audio and video quality of NowTV non-HD channels is very bad, much worse than TVB/ATV terrestrial channels. PCCW constantly promotes itself as a high tech company, but their product is much worse than other broadcasts in HK and overseas. Besides picture quality, the video signal is still broadcast in 4:3 ratio, instead of 16:9 widescreen. All TVs sold today are 16:9, and the majority of users who can afford PCCW's service are most certainly using 16:9 TVs, so why do we still have to view the NowTV signal with black bars top and bottom? If we use the "zoom" function of our TV or the NowTV decoder box, then the picture quality deteriorates even further and we often lose the chinese subtitles at the bottom. This is clear evidence of not keeping up with technology which is over 10 years old, and yet PCCW still promotes itself as a high tech company.
- 3. Excessive advertising despite collecting relatively high monthly subscription fees from users, PCCW still has too many adverts on their channels, especially in the middle of live sporting events such as Formula 1. PCCW clearly is not operating a healthy business if they have to sell so much advertising on their channels.

I hope my comments will be useful in your evaluation of the renewal of PCCW's license. I strongly believe they need to improve their service to compare with other cities such as Singapore, Tokyo and London.

本人就電訊盈科媒體有限公司本地收費電視節目服務牌照續期公眾諮詢有以下意見: 1) 本人光顧電訊盈科收費電視(下稱now tv)約有4年時間,由於本人較喜歡看足球直播賽事,故當時與now tv簽訂服務合約時是以每月港幣128元的費用享用服務,主要頻道為now sport 632至637頻道,當中包括當時獨家直播的西班牙甲組聯賽(下稱西甲)。至2013年8月,now tv銷售部門致電本人,表示他們取得英格蘭超級聯賽(下稱英超)的播映權,詢問本人有否興趣升級月費計劃觀看,每月費用299元,合約期2年,當中除附送600 now dollar外,還括免一個月月費。

但近期本人就2個問題向now tv 作出查詢:

- 1) 本季西甲直播賽事場數比以往明顯減少,而得到now tv的回覆是的確地比以往減少,但亦至少每週有四場直播場事,而減少的原因是由於now tv本季主打賽事為英超,為顧及不同客戶的需要而作出調整。而為了補償本人損失觀看西甲直播的機會,now tv表示就西甲直播賽事減少而括免本人一個月月費。
- 2) 本人與now tv升級合約時的括免一個月月費事宜, now tv表示括免的費用是288元, 而不是299元。原因是本人的合約是訂購3個不同頻道,包括體育頻道、336頻道及554頻道。而本人表明當時是以299元月費訂購體育頻道,沒有訂購另外2條頻道,故月費括免應為299元,而本人要求翻查簽訂合約的電話錄音,但Now tv竟然回覆本人錄音是不會給客戶聽取,而是由他們的部門聽取後再給我回覆,那本人實感不公平,他們大可對錄音「做手腳」,至今仍未得到now tv的回覆。

就以上兩個查詢,本人認為now tv的銷售手法極有問題,本人升級月費計劃後,因now tv所謂的顧及不同客戶需要而令本人觀看心儀的賽事機會減少,感覺尤如付出更多金錢,而被追減少選擇。

至於月費減免銷售手法方面,雖然只是11元的少數目,但正正反映now tv的銷售手法,而收聽合約時的電話錄音,更加給人「黑箱作業」的感覺。

雖然未知以上意見與本人就電訊盈科媒體有限公司本地收費電視節目服務牌照續期公眾諮詢是否相關,但如對 貴局作出續牌前,亦請多加考慮以上的意見,如有需要,本人願意提供更多相關資料予 貴局,謝謝!

Generally the content and service of PCCW Media's nowTV platform is of a very high and impressive standard.

A couple of areas of concern would be:

- 1. The difficulty for a subscriber to change the choice of channels mid-way through a contract. PCCW use the opportunity of a subscriber wanting new or different channels to re-negotiate a long term agreement and 'tie-in' the subscriber for future months or years. This is particularly an issue with the high number of transient residence in Hong Kong who may not be able to benefit from a longer term arrangement.
- 2. When cancelling your service it is very difficult to get hold of the right (or any) person who can activate a cancellation. And failure to pay a months subscriptions (even if you have informed PCCW that you no longer want the service) can result in a credit agency chasing for 'over-due' payments.
- 3. The use of credit agencies to chase bills is not something I would want PCCW to continue with
- 4. The packaging of channels is very confusing and leads to the requirement of subscribers and potential subscribers having to engage with sales staff who very often use this as an opportunity to come to yor house and pressure you to buy additional products or services (as as an additional modem or faster broadband) in addition to additional channels
- 5. Pixalation and screen freezing especially on live action and sports channels, is still an issue
- 6. More information and promotion on "Player" services (such as FOX Sports Player or HBO GO) in English would be appreciated.
- 7. More information and promotion on discounts for bundled services (Broadband, mobile and TV) would also be helpful
- 8. Choice and variety of channels is pretty good (especially compared to the other PayTV operators) but more local channels or channels with local relevance especially for children and families / activities etc. would be good

Everywhere else, the consumer is king. Here, he is more like a sucker with little to fall back on except the principle of "buyer beware", thanks to the "little government, big market" philosophy much favoured by the Donald Tsang Yam-kuen administration.

The mainland may have toxic products but at least it provides fair pay-TV services. Here, the market is dominated by i-Cable and Now TV, with 1.09 million and 1.16 million subscribers respectively. They are locked in a battle for the local couch potato.

Their weapon of choice is the broadcast rights of the English Premier League games. These rights swing back and forth between them. Now TV won the latest bidding war, reportedly paying nearly HK\$1.5 billion for three seasons starting last year. And guess who ultimately pays? As a Chinese proverb says, "The wool comes only from the lamb's back". Like lambs, we are ripe to be fleeced.

Pay TV comes under the Office of the Communications Authority, which defines its role and function as enforcing the codes of practice in three areas: programming standards; advertising standards; and technical standards. These standards are designed to regulate free-to-air TV.

With pay TV, the authority takes a "market-driven" approach. I was struck dumb when it says that pay TV doesn't enjoy the same market penetration and influence as free-to-air TV, and therefore deserves greater latitude, as is the case in other developed markets. The authority is asleep, while the market has marched on. Today, pay TV has a combined subscribership of more than two million in a city of seven million, with terrestrial television in decline. How can it justify zero oversight on such a huge market penetration?

Besides, pay-TV stations are not shops. They are public television, with public trust at its core, entailing a contract between providers and subscribers. Is the authority saying that this is only a matter for the Consumer Council? If so, it should opt out totally. Pay TV is basically a middle-man operation, with acquired programmes as the staple. Its self-produced or co-produced shows are meagre offerings. As such, pay-TV operators should let subscribers choose their own viewing experience.

Instead, they dictate our viewing options for their own gain. They do so through a cunning concept called "bundling". Elsewhere, this is a benevolent concept, giving subscribers discounts for using telephone, internet and TV services simultaneously. But, here, bundling has an ugly twist.

Now TV, for example, clusters Premier League telecasts with other sports programmes, forcing subscribers to cough up HK\$288 per month for one sports package alone. Now TV's monthly average revenue per user in 2012 was HK\$173.

With bundling, some viewers are paying over HK\$600 per month with non-sports selections.

It is thus using the Premier League broadcasts to poach subscribers from i-Cable (which is none of our business) and inflate rates, ruthlessly dictating viewing options (which is our business).

People cried foul when utility companies raised their rates by 4 per cent. Television is no less a public service. Yet the authority is blissfully unaware of viewer anger over rampant gouging and choice restrictions in a substantial market.

Contract agreements guaranteed the renewal of channel choices on the same terms. Through bundling, these terms are unilaterally changed with impunity. Many low- and middle-income subscribers feel the pain in their purse.

Locals are drawn to English soccer, not for love of the beautiful game, but to place bets. With the Winter Olympics in full swing, Now TV fails to carry a single item on most days, as if the Olympics isn't happening. This betting madness, to the exclusion of other sports, is bad for sports development.

The recent uproar over free-to-air TV licences is a naked consumer revolt over viewing choices. If Leung Chun-ying can end unfair pay-TV practices, he will recoup support among many suffering users.

As the first SAR leader to abandon tycoon-tilting policies, Leung is our last hope. With consumer protection agencies toothless, we need our chief executive to champion the public interest.

Business is predicated on the principle of giving the consumer what he wants. But we are denied the right to customise our viewing preferences.

The laissez-faire policy in Hong Kong has outlived its usefulness. The authority must set new terms for its next tendering process when Now TV's licence comes up for renewal next year.

This was once a land of fairness. Our tycoons forget that. Why not bring a smile to the faces of your customers, instead of curses on their lips? If other pay-TV markets are fair, why isn't ours? It's time we reclaimed the sovereignty of the consumer.

We need a fair society more than a so-called free economy.
